  - I. A modification or withdrawal of bid after the deadline for submission of bid(s) and during the validity period.
  - II. Refusal by the bidder(s) to accept an arithmetical error or otherwise appearing on the face of bid(s).
  - III. Failure the part of the successful bidder to deposit performance security@5% of the bid value.
  - IV. Failure on the part of successful bidder to execute the contract as per term and conditions stipulated in the tender document.
  - V. No interest shall be payable on the EMD amount.
- 4. - **6.** Alternative bids shall not be considered. Only one tender can be applied by the person/individual or in partnership. Failure to comply this condition will attract the cancellation of participation of concerned firm and forfeiture of EMD.

- 7. Bidders should submit technical and financial bids. The technical bid and the financial bid be sealed by the bidder in separate covers duly super-scribed. <u>Cover-1</u> contain all required technical documents along with EMD & Tender Fee and <u>Cover-II</u> contain only Financial Bid. - 10. No advance will be given to the successful bidder.
- **11.** The bidders will be responsible for all necessary arrangements for installation of articles as defined in scope and time period.
- **12.** The GST registration Number and PAN of the participants/firm also be attached with the quotation.
- **13.** Rate quoted should be inclusive of all taxes/charges including GST.
- 14. Average annual financial turnover of last three years should not be less than Rs. 50.00 Lakh (Rupees Fifty Lakh Only) Certificate in this regard issued from the Charted Accountant should be attached with Technical Bid.

- **15.** The Firm/bidder should not be black listed by any Govt.
